This course focuses on gender and sexuality, tracing the emergence of the concepts across time, space and knowledge. Current theories on the concepts will be followed by significant themes within discussions of gender and sexuality from the physical to the social, namely those of the body, emotions, health, violence, law/state, culture, and race and ethnicity.

Every week, I shall introduce the framework for discussion through an interactive lecture; a team of two students will then lead the discussion of the readings, followed by a general discussion.
