#### INTRODUCTION TO HEALTH ECONOMICS

**Course goals:** This course provides an overview of the economics of health and medical care. By the end of the quarter students should have the institutional knowledge and analytic tools needed to contribute to current public policy debates about health and medical care.

**Prerequisites:** At least one semester of introductory microeconomics.
