FTAs in General


Types

- Free Trade Agreement (FTA)
 - Zero tariffs on (most) imports from partners
 - Unequal tariffs on imports from outsiders
 - Rules of origin (ROOs)
- Customs Union
 - Zero tariffs on imports from partners
 - Common external tariffs on outsiders
 - No need for ROOs
- Common Market
 - Customs Union plus other free movement

FTAs in General

- Proliferation: Now more than 300, involving a significant fraction of possible country pairs
- Most are FTAs
- WTO reports all as Regional Trade Agreements (RTAs), though many include distant countries






Note: Notifications of RTAs: goods, services & accessions to an RTA are counted separately. The cumulative lines show the number of RTAs/notifications that were in force for a given year. NAFTA


- What it was
 - An FTA between US, Canada, and Mexico
 - Went into effect Jan 1, 1994
- Effects
 - Trade
 - Wages
 - Employment
 - Supply chains
 - Consumers

NAFTA Effects

Trade

- Grew massively across N. America
- US bilateral trade with Mexico became deficits: US imports > US exports
- Supply chains, especially in autos, extended across North America

(billions of nominal U.S. dollars)



Figure 2. Non-Petroleum Trade with NAFTA Partners: 1993-2014




U.S. trade deficits increased after NAFTA came into effect.

- Wages
 - Fell in Mexico
 - No effect on average in US


What Happened: Mexico

Unemployment: No effect (or fell)




NAFTA Effects


- Supply chains
 - US manufacturing moved inputs to low-cost locations across N. America














NAFTA Effects

- Consumers
 - As always with freer trade, the ultimate beneficiaries are consumers
 - Lower prices for
 - Imported consumer goods
 - Domestically produced goods and services that use cheaper imported inputs
 - Greater variety of goods to choose from
 - These gains are hard to measure
 - One indicator may be the low rates of price inflation experienced under NAFTA

USMCA

- What it is
 - "United States, Mexico, Canada Agreement"
 - Result of Trump's renegotiation of NAFTA
 - Mostly the same as NAFTA
- Why replace NAFTA?
 - Trump opposed NAFTA as early as 1993
 - "The Mexicans want it, and that doesn't sound good to me."
 - Opposition to NAFTA was popular

USMCA Timeline

- Renegotiation
 - May 18, 2017: Renegotiation began
 - Aug 27, 2018: Agreement between US and Mexico
 - Sep 30, 2018: Agreement with Canada to join
- Approval and Implementation
 - Dec 19, 2019: US House approved (contentious)
 - Jan 17, 2020: Senate approved (expected)
 - Jan 29, 2020: Trump signed into law
 - Jul 1, 2020: Agreement goes into effect

USMCA Features

- Car incentives
 - ROO raised from 62.5% to 75%
 - 70% of steel & aluminum must come from NA
 - 40-45% of value added from >\$16/hr labor
- Dairy: Some opening of US dairy to Canada
- ISDS only between US & Mexico
- Commitments on labor & IP standards
- "Sunset Clause" Review after 6 years
- Inform US if negotiate with NME (China)
- Commitment not to manipulate currencies

Recent FTA News

- Africa
 - AfCFTA: African Continental Free Trade Area
 - Came into force May 2019
 - "Strips away tariffs on 90 per cent of goods"

- EU and Canada
 - CETA: Comprehensive Economic and Trade Agreement
 - FTA between EU and Canada
 - Implemented 2017
 - Includes "export quotas" for agricultural products
 - Includes MFN clause, relevant for EU-UK FTA


- EU and MERCOSUR (CU of Brazil, Argentina, Uruguay, & Paraguay)
 - FTA "sealed" in June 2019, but not yet ratified
 - Ratification was to begin in 2020
 - Advantages expected:
 - Access to Brazil for EU industrial goods and wine
 - Access to EU for South American beef, poultry, and sugar
 - Problems with ratification include:
 - "decision to allow sugarcane cultivation in the Amazon region."

- EU and Mexico
 - EU & Mexico had FTA from 2001. This is to replace it.
 - Features:
 - Duty-free trade in almost all goods
 - Measures to fight corruption and money laundering
 - Investment protection,
 - Sustainable development
 - Simpler customs rules to boost exports.

- EU and Vietnam
 - EVFTA: EU-Vietnam Free Trade Agreement
 - Approved in Vietnam June 8, 2020
 - Features
 - Zero tariffs immediately on 65-71% of trade
 - 99% of other tariffs phased out over 7-10 years
 - Trade is mostly textiles and apparent to EU, aircraft and cars to Vietnam
 - Models predict Vietnam growth by 2030 of 2.4% in GDP and 12% in exports

Recent FTA News: China

RCEP

- RCEP: Regional Comprehensive Economic Partnership
- Large FTA being negotiated since 2013 by
 - ASEAN 10 countries plus 5: China, Japan, South Korea, Australia and New Zealand
 - India also, until it recently dropped out
- "Bulk of negotiations" done last November
- Hope to finish by end of 2020

Recent FTA News: China

- China and Iran (reading optional)
 - Iran and China are believed to have reached agreement on an "economic and security partnership"
 - Agreement covers
 - Chinese operations in Iran in "banking, telecommunications, ports, railways and dozens of other projects"
 - Discounted supplies of oil over the next 25 years.
 - Military cooperation

- UK couldn't do deals while still in EU, since it's a customs union

 - Tariffs? No

- Needs FTA with EU to replace its status as member
 - Even with FTA, EU will check some imports,
 such as food, as it does other non-EU imports

- EU has about 40 deals with about 70 countries
- Post-Brexit UK trade deals done:
 - 19 deals covering 50 countries, about 8% of its trade (list on next slide)
 - Largest:
 - Switzerland (£32.4bn of trade in 2018)
 - South Korea (£14.8bn in 2018)
 - Also: Japan, as of 10/23/20



% of total UK trade in 2018


Countries with EU trade agreements

UK's top 10 trading partners in 2018



- Japan-EU
 - (Deal completed 10/23/20)
 - Japan resists deal better than with EU
 - UK (as of August) wanted better deal on British Stilton cheese
 - Would be "symbolic" that Brexit was worth it

UK-US

- Talks began in May, with 30 groups
- UK benefits of deal: increase UK GDP by 0.15% over 15 years.
- Difficulties
 - Uncertainty about EU-UK deal
 - US election
 - Farming standards: UK doesn't want
 - chlorine-washed chicken
 - genetically modified crops

- UK-US (cont.) WSJ on Issues
 - What <u>are</u> hard:
 - U.K. Agricultural trade ("a needless sticking point")
 - US insistence on scientific food-safety standards
 - chlorine-washed American poultry and beef treated with certain medications
 - Britain's socialized National Health Service
 - U.K. imposed its version of a digital services tax on American tech giants in April
 - Trump's tariffs in the Boeing-Airbus dispute

- UK-US (cont.) WSJ on Issues
 - What should be hard:
 - banking regulations
 - mutual recognition of professional qualifications
 - reciprocal recognition of product-safety rules and inspections

- Not including US: CPTPP =
 Comprehensive and Progressive Trans Pacific Partnership
 - US pulled out of TPP under Trump
 - Now wants FTA with many of its members
 - To undo the disadvantage of being out
- US is now seeking FTAs with several CPTPP countries:
 - Japan, Australia, New Zealand, Vietnam

- Georgia-US
 - This is probably <u>not</u> happening, but is advocated in a reading by Bacchus, former Congressman and also Chair of WTO Appellate Body
 - Reasons given:
 - Georgia deserves it
 - Support for democracy
 - Moral case: Georgia serves with US in Afghanistan

- Kenya-US
 - Feb 2020: Trump announced negotiations
 - Kenya is US's 98th largest trading partner
 - But deal would be model for deals with other
 African countries
 - Fear is that US will lose out to China and its Belt and Road Initiative
 - Kenya already has preferences under AGOA, but it doesn't cover all trade and might not be renewed.

- Taiwan-US
 - Aug 2020: Taiwan President wants FTA with US
 - Previous attempts were stepped by Taiwan's restrictions on imports of US beef and pork
 - Stopped in 2003 due to mad cow
 - Now they block them due to additives
 - President seems to think this issue can be resolved
