
FTAs in General

Types

- Free Trade Agreement (FTA)
 - Zero tariffs on (most) imports from partners
 - Unequal tariffs on imports from outsiders
 - Rules of origin (ROOs)
- Customs Union
 - Zero tariffs on imports from partners
 - Common external tariffs on outsiders
 - No need for ROOs
- Common Market
 - Customs Union plus other free movement


FTAs in General

- Proliferation: Now more than 300, involving a significant fraction of possible country pairs
- Most are FTAs
- WTO reports all as Regional Trade Agreements (RTAs), though many include distant countries







NAFTA


- What it was
 - An FTA between US, Canada, and Mexico
 - Went into effect Jan 1, 1994
- Effects
 - Trade
 - Wages
 - Employment
 - Supply chains
 - Consumers

NAFTA Effects

Trade

- Grew massively across N. America
- US bilateral trade with Mexico became deficits: US imports > US exports
- Supply chains, especially in autos, extended across North America

Figure 1. U.S.-Mexico Trade in Goods and Services (1993-2015)




Figure 1. U.S. Merchandise Trade with NAFTA Partners: 1993-2014

(billions of nominal U.S. dollars)






U.S. trade deficits increased after NAFTA came into effect.

- Wages
 - Fell in Mexico
 - No effect on average in US


What Happened: Mexico


Deals

 - Pockets of disruption across US


What Happened: U.S.

Unemployment: No effect (or fell)




- Supply chains





NAFTA Effects

- Consumers
 - As always with freer trade, the ultimate beneficiaries are consumers
 - Lower prices for
 - Imported consumer goods
 - Domestically produced goods and services that use cheaper imported inputs
 - Greater variety of goods to choose from
 - These gains are hard to measure
 - One indicator may be the low rates of price inflation experienced under NAFTA

USMCA

- What it is
 - "United States, Mexico, Canada Agreement"
 - Result of Trump's renegotiation of NAFTA
 - Mostly the same as NAFTA
- Why replace NAFTA?
 - Trump opposed NAFTA as early as 1993
 - "The Mexicans want it, and that doesn't sound good to me."
 - Trump sees trade as zero-sum game
 - Opposition to NAFTA was popular

USMCA Timeline

- Renegotiation
 - May 18, 2017: Renegotiation began
 - Aug 27, 2018: Agreement between US and Mexico
 - Sep 30, 2018: Agreement with Canada to join
- Approval and Implementation
 - Dec 19, 2019: US House approved (contentious)
 - Jan 17, 2020: Senate approved (expected)
 - Jan 29, 2020: Trump signed into law
 - Jul 1, 2020: Agreement goes into effect

USMCA Features

- Car incentives
 - ROO raised from 62.5% to 75%
 - 70% of steel & aluminum must come from NA
 - 40-45% of value added from >\$16/hr labor
- Dairy: Some opening of US dairy to Canada
- ISDS only between US & Mexico (was for all in NAFTA)
 - ISDS = Investor-State Dispute Settlement
- Commitments on labor & IP standards
- "Sunset Clause": Review after 6 years
- Inform US if negotiate with NME (China)
- Commitment not to manipulate currencies



RCEP

RCEP

- "Regional Comprehensive Economic Partnership"
- Large FTA negotiated since 2013 by
 - ASEAN 10 countries plus 5: China, Japan, South Korea, Australia and New Zealand
 - India also, until it recently dropped out
- Signed Nov 15, 2020



CPTPP

- "Comprehensive and Progressive Trans-Pacific Partnership"
- Successor to TPP after Trump pulled US out
- Includes 11 countries, including
 - Japan
 - Canada
 - Mexico
 - Australia
 - Chile

Other FTA News

UK-US

- Brexit was motivated, in small part, by UK wanting freedom to have FTA with US, which it could not do as part of EU customs union
- US under Biden is not pursuing this
- UK government still wants it, but population is concerned about US food standards
 - Chlorinated chicken

Questions on Segal, "'Chlorinated' US Chickens..."

- Why are chickens a sticking point in the negotiation of a trade agreement between the UK and the US?
- Why is this said to be a deeper issue than just chicken?
- What is the "precautionary principle" and how is it relevant here?
- How much of US chicken is actually chlorinated?

Other FTA News

- Africa: AfCFTA
 - "African Continental Free Trade Area"
 - Founded 2018, in effect since Jan 1, 2021
 - Includes 54 of the 55 African Union countries

Questions on Pilling, "African countries not ready ..."

- How many had ratified it as of this writing?
- In what ways are the countries not ready?
- What is the main purpose of AfCFTA?
- What is the relevance of "economies of scale"?

Other FTA News

- EU and other
 - Switzerland:
 - Not EU member but has many agreements
 - Frictions may undermine these
 - India: Discussion of FTA has been renewed
 - Mercosur
 - EU-Mercosur FTA was signed in 2019
 - Still not ratified, and may never be

Questions on FT, "Switzerland's slow-motion Swexit"

- What, apparently, is "Swexit"? Is it Switzerland leaving the European Union?
- What benefits does Switzerland enjoy with respect to the EU?
- Who wanted these negotiations for a "framework agreement" and why?
- Was it the Swiss government that ended this by pulling out of the negotiations?

Questions on Fleming & Brunsden, "EU and India agree to relaunch ..."

- Have the EU and India had talks like these before?
- What motivates them to talk now?
- What are some of the contentious issues between them?

Questions on Brunsden & Fleming, "... EU 'credibility' on the line ..."

- What is holding it up the EU-Mercosur FTA?
- Does the agreement remove all of Mercosur's tariffs on EU exports?
- How are views divided among EU countries?
- Why is re-opening the agreement said to be a bad idea? What is the alternative?

Other FTA News

- UK and other
 - First job after Brexit was to get new FTAs with EU FTA partners
 - Now free to do FTAs with new countries
 - Australia (as of Jun 16, 2021)
 - New Zealand (as of Oct 20, 2021)
 - Has also applied to join the CPTPP

Questions on Economist, "Britain successfully rolled over"

- How many trade deals had the UK completed by the date of this article (January 20, 2021)?
- Why were these deals easier to reach than future ones will be?

Questions on Nelson, "Britain ... Deal With Australia"

- How long did these negotiations take?
- Will this eliminate all tariffs? When?

Other FTA News

- US and other
 - Negotiating with Taiwan
 - Earlier negotiations collapsed
 - Now restarting
 - Signed a "Limited Trade Deal" with Brazil
 - Note that Brazil is part of Mercosur, so not free to do FTA with US

Questions on Zumbrun & Deng, "U.S., Taiwan Revive Trade Talks"

- These talks are being restarted. What had been a "sticking point" for such negotiations previously?
- The countries pledged to "keep supply chains free of forced labor"? Why?
- Do they expect an agreement as comprehensive as the USMCA?

Questions on Swanson, "U.S. to Sign ... Deal With Brazil"

- Why was Trump negotiating such "mini" trade deals, and with whom has he succeeded?
- Why could it be agreed and finalized so quickly?
- What does this say the deal will do?
- What does this do to tariffs?

Other FTA News

- Other
 - Uruguay is seeking FTAs with countries outside Mercosur

Questions on Mander, "Uruguay roils Mercosur bloc ..."

- What countries are part of Mercosur, and what kind of trade agreement is it?
- Why does Uruguay want to do separate trade deals with outside countries?
- Is it possible for a member of Mercosur to agree on tariff cuts with outside countries?
- Does Mercosur as a group have any trade agreements with outside countries?
