- MICROFILMS: Steve Schaffer; This is a gentle reminder that everyone making presentations in DMG sections of the IADR-AADR meeting in San Francisco is required to submit a manuscript for the microfilm / microfiche. To limit costs for the process, please use 8-1/2 x 11 or A4 paper; single space the text; do NOT use a cover page; place the title, authors, abstract number, and address on the first page; place your name, abstract number and IADR-AADR 1996 at the top right of every page; limit the manuscript to 10 total pages (including illustrations); and insure that all photographs are glued and captioned, placing several photographs on a single page if possible.
- Manuscripts will NOT be collected at the meeting. PLEASE MAIL THE MANUSCRIPT to the Editor before the meeting or within 2 weeks following the meeting. Introduction to Biomaterials Properties

These tables are provided by Biomaterials Research Center at The University of Michigan School of Dentistry.

Biomaterials Properties reports the properties of materials that have been reported in the scientific literature. The purpose of providing the information here is to keep the tables updated with current data. The database started in 1979 when published as an appendix compiled by Dr. John M. Powers in "Dental Materials: Properties and Selection", edited by W.J. O'Brien and G. Ryge. It was further expanded by Carole Groh in a similar appendix in "Dental Materials: Properties and Selection" edited by W.J. O'Brien. Chicago: Quintessence Publishing Co., Inc., 1989. Quintessence Publishing has granted Dr. O'Brien permission to publish these tables in electronic format. In 1995 another major expansion occurred.

Our intention is to keep the database current by adding new data as it is published, and to add new categories including wear. If you have published or know of data that should be included in these tables, we welcome your input. It would be helpful if submissions were in the following format: Property, Type of material, Brand name (if available), Value (with appropriate units), and Reference citation.
