

# 2008 Ann Arbor City Junior Tennis Tournament

**FORMAT** shall be best 2 of 3 sets; a 12 point tiebreaker will be played in lieu of a third set. There is a first round consolation for singles; doubles is single elimination. Default time is 10 minutes from the scheduled match time. Players should be prepared to play three matches a day. Parents please note: no coaching or assisting with rules or line calls.

**RESIDENCY & AGE REQUIREMENTS:** All players must be residents of Washtenaw County. Age requirements are per USTA guidelines; players must be amateurs who do not exceed the maximum age by the last day of the month during which the tournament is scheduled to start. Age divisions are 10, 12, 14, 16 and 18 years. Players are eligible to play in any age division provided they have not exceeded that age by June 30, 2008.

**ENTRY FORMS** are available on the AAACATA website in PDF format (www.aaacta.org) and at the Community Rec & Ed offices, Cayman Sports, local public courts and area tennis clubs. Each player may enter only one singles and one doubles event.

**ENTRY FEES** are non-refundable and include balls for matches, trophies for finalists and choice of a t-shirt or tote bag for all participants.

**DRAWS:** players will be notified of reporting times and sites for first round matches by July 23; draw will be posted on the AAACATA website by July 23.

*The Ann Arbor Area Community Tennis Association (AAACTA) and the Community Education and Recreation Department invite you to participate in the 2008 Ann Arbor City Junior Tennis Tournament. The Tournament is open to residents of Washtenaw County and will be played at the University of Michigan Varsity Tennis Center and Pioneer High School. All participants will receive their choice of a tournament T-shirt or tote bag, and all finalists will receive trophies. Proceeds from the tournament support the youth tennis programs of AAACATA, a non-profit 501(c)(3) organization.*

**RAIN POLICY:** Report to tournament site 15 minutes before the start time, RAIN OR SHINE. The Tournament Director will determine whether or not to delay matches or to reschedule. At the Director's discretion, play may be moved indoors; players will be responsible for indoor court fees.

**CAUTION:** Players should exercise caution in extreme heat and humidity; please bring adequate water and other supplies.

**MUELLER AWARD:** All players in the tournament are encouraged to apply for the Mueller Award. Application forms are available on the AAACATA website at www.aaacta.org.
